2017 was a challenging, dynamic, busy and fulfilling year. To meet the challenges, Horizon continued to grow and improve both our services and our organizational capabilities. ### Horizon featured in WNED-TV documentary

Horizon was the only treatment agency depicted in Understanding the Opioid *Epidemic*, a documentary produced by WNED-TV and aired nationally on PBS. The program addressed possible solutions to the crisis, including more drug-free treatments for pain management, improved prescribing of opioids, and reducing the amount of opioids produced and prescribed in America. Interviews with several Horizon employees, including Anne Constantino, president and CEO, were filmed at Terrace House and Horizon Village. Cameras also documented group therapy sessions and wellness classes. Horizon was involved throughout the two-year production and editing process, and also contributed to an accompanying classroom curriculum for seventh and eighth grade students. The documentary is available online.

#### **Guiding healthcare reform**

Horizon executives are contributing their expertise to New York State's Delivery System Reform Incentive Payment (DSRIP) initiative. Their participation has influenced how datadriven enhancements in behavioral health services are being introduced to improve the Medicaid population's overall health and help the state meet its goal of reducing avoidable hospitalizations by 25% over five vears. In Western New York, Millennium Collaborative Care (MCC) is one of the performing provider systems working to these purposes. Anne Constantino is a member of MCC's board of managers which represents community-based organizations. Several other Horizon executives serve on MCC advisory committees.

### Using empathy to create the best patient experience

Horizon's H.E.A.R.T. program, developed in partnership with the Cleveland Clinic, expanded in 2017 with the introduction of a new phase, Coach with H.E.A.R.T. Because every employee contributes to a patient's overall experience, everyone receives training that emphasizes empathy in all interactions. Volunteers in every Horizon department are trained to help their colleagues apply the H.E.A.R.T. skills—Hear, Empathize, Apologize, Respond, Thank—to effectively handle often challenging situations.

### Faster action for first responders

Horizon developed a program that enables expedited access to substance use care for first responders and veterans in partnership with BlueCross BlueShield of WNY and the Erie County Medical Center (ECMC). With one call, City of Buffalo first responders and veterans can obtain an assessment for immediate admission to ECMC for private substance use withdrawal services or to Horizon's Freedom Village for residential treatment. After withdrawal at ECMC. patients may be admitted directly to Freedom Village, where they continue their recovery journey with clinicians specially trained to address their needs.

#### Horizon reputation draws the attention of the nation's drug czar


Seeking our perspective on the opiate epidemic and barriers to treatment, representatives of the Office of National Drug Control Policy (ONDCP) toured Horizon Village Terrace House in September. Richard J. Baum, acting director, was accompanied by ONDCP's outreach liaison and community engagement coordinator, and its acting deputy chief of staff and chief operating officer. The visit included a discussion of Horizon's treatment strategies and recommendations in the fight against addiction, as well as conversations with Horizon patients and family members.

### **Residential Redesign** certification

Horizon Village was the first treatment program to secure certification as a residential treatment center by the NYS Office of Alcoholism and Substance Abuse Services (OASAS). This certification allows our patients to progress seamlessly from residential drug withdrawal, to emotional/health stabilization, to intensive personal and family rehabilitation, and to community reintegration with outpatient care. Insurance companies are increasingly reimbursing residential care based on its demonstrated success.

#### **Advocacy works!**

Horizon is actively involved in public policy conversations at the state and national levels, advocating for changes to benefit our patients and advance our field. One example is our successful advocacy to permit nurse practitioners and physician assistants to prescribe buprenorphine for the treatment of opiate addiction. The previous restriction of their prescribing only for pain relief undermined our ability to serve the many patients in need. In addition, we engaged successfully in defeating proposals to end the ability of Credentialed Alcohol and Substance Abuse Counselors to practice in behavioral healthcare organizations. This would have exacerbated the state-wide workforce shortage. Horizon is also continuing to advocate on behalf of our counselors for student loan forgiveness to support our ability to recruit and retain qualified staff members as well as address this workforce shortage.

### Controlling health insurance costs

In an effort to reduce cost volatility, Horizon joined a health insurance "captive" — a type of self-funded employee health benefit plan that offers benefit flexibility, fiscal control and transparency. A proactive wellness component encourages staff members to seek medical screenings for early detection of potential health problems.



### Horizon leadership honored by HEALTHeLINK

HEALTHELINK is a secure CHEALTHELINK technology platform that enables health providers and insurers to share patient information efficiently and privately. Recognizing that behavioral health is integral to overall wellbeing, HEALTHELINK sought Horizon's expertise to share this information with primary physicians, specialists, hospitals and other caregivers. The organization honored Horizon as a Leader in Healthcare Innovation.

### ATM convenience for patients

With our purchase of two ATMs, Horizon Village patients now enjoy easier access to their monthly entitlement personal needs allowances. Funds are deposited on debit cards provided by Horizon, and patients use them to obtain cash from the ATMs. In addition to improved responsiveness to patients, the new system simplifies allowance management by our finance staff.

### Annual Mission and Excellence Award goes to Nicole Tobey

At our annual board meeting in May, Nicole was honored for her exceptional achievement in establishing and growing Horizon's Health Home Care Management Program. Health Home care managers coordinate treatment and services among a wide range of providers and entitlement programs, guiding patients and resolving issues that might impede their recovery. Since starting on a small scale in 2013, the program Nicole leads now has 29 employees assisting almost 700 patients in Erie and Niagara Counties. All three Horizon boards and our entire executive team looked on as Michelle Curto, vice president of administrative operations, presented the award.

### Horizon acquires new corporate headquarters

Horizon has outgrown its current administrative facility and will relocate to 55 Dodge Road in Getzville. The new space will facilitate collaboration among all administrative management teams and accommodate our expanding operations.



### Horizon chosen to host state funding press conference

State Senator Tim Kennedy's announcement of increased funding to combat the state's opiate crisis took place at Horizon. Explaining that \$16 million of the \$213 million allocation would come to our region, Kennedy cited "the incredible providers like Horizon Health who go above and beyond for those who find themselves dependent on these drugs." Anne Constantino expressed gratitude to Governor Cuomo "for acknowledging how vital resources are to all communities," adding that "we know treatment works, and that people can recover and go on to live happy, healthy and productive lives."

#### **Embracing diversity**

The Horizon Diversity Committee was established to foster sensitivity and responsiveness to the cultural beliefs, attitudes and practices of patients and staff members, and thereby empower Horizon to deliver improved care.

#### **Aurora Village nearing completion**


Aurora Village will provide 25 critically-needed residential treatment beds for women ages 18 and older who are struggling with serious substance use disorders. Like all Horizon residential treatment centers, it will offer comprehensive services for both patients and their families. Aurora Village is on target to open in August 2018.



Horizon Village residents benefit from a holistic approach to recovery that focuses on their health, wellness, vocational, educational, social and spiritual needs. Each resident has a primary counselor. Clinical staff members are available seven days a week. Evidence-based treatments are combined with alternative therapies including art, music, gratitude practices and guided meditation. Patients also benefit from GED, college prep and job readiness classes, self-help meetings, recreational activities, wellness/fitness programs and more.

### Promoting recovery with new ways to have fun

Young people often give up their hobbies and pastimes — and many other healthy activities they once enjoyed — when substance use takes over their lives. Horizon successfully competed for a grant from OASAS to create programming that helps patients avoid the boredom and lethargy that could jeopardize their recovery.

Our program exposes young adult residents and program alumni to social, recreational, cultural, intellectual and spiritual resources in the community. The grant supports a myriad of outings, from bowling nights and self-help meetings to visits to the Memorial Art Gallery, the Botanical Gardens and the Buffalo Zoo. Improvisational art and yoga classes bring alumni back to the campus, maintaining their connection should they need our services again, and helping current residents see that a fulfilling and fun recovery is possible.



#### **Cutting-edge training to assist veterans**

The Veterans Administration has identified Eye Movement Desensitization and Reprocessing (EMDR) as an evidence-based practice for treating veterans who suffer from post-traumatic stress disorder (PTSD). Thanks to a two-year,



\$4,0,000 grant from the National Fuel Gas Company, nine clinical staff members received intensive EMDR training over several months, and are now either certified or nearing certification. As a result, Horizon can now provide EMDR both for residents at Freedom Village and for patients at our mental health clinic in Sanborn. So far, 136 unique patients have been treated with 439 sessions of this innovative therapy that helps patients with PTSD manage their past painful emotional experiences.

"I have experienced positive changes toward my past experiences when completing an EMDR session. It helps me cope with memories that have haunted me for many years."

"I didn't really want to try it but, boy, was I wrong.

EMDR takes you back to those times that were painful and traumatizing and allows you to understand the trauma and fix some of the damage it caused...It works and is a great tool to have."

"This technique has been extremely helpful to me for dealing with anxiety.

There are many things in my past that I have always thought were not completely processed. I am now able to do this using this tool."

### Faster access to mental health services

A \$25,000 grant from the NYS Office of Mental Health enabled Horizon to implement Intensive Outpatient Program (IOP) services for individuals struggling with mental illness. These services provide patients expedited access to medications and intensified counseling services designed to avert serious relapses and hospitalizations. Our plan is to expand these services to several of our facilities.

#### **New Light Court Group Room at Horizon Village**

On a tour of Horizon Village, East Hill Foundation board member Julia Spitz targeted this space for a facelift. The resulting \$15,000 grant supported the creation of a safe, bright and comfortable environment for patients engaging in group counseling, visiting with their families, or relaxing and socializing during free time.

Patients, families, alumni, employees and friends from across the community turned out to support hope and recovery for people dealing with mental health and substance use disorders. More than 250 walkers circled the loop in Delaware Park while Horizon Village residents offered support as volunteers. The event, which grows every year, surpassed its fundraising goal by raising \$36,000- our highest total ever.

#### **Buffalo Bills Alumni stage Kick the Habit Weekend**

The 2017 Buffalo Bills Alumni Weekend took the lead in the fight against the opiate epidemic that is devastating the community. Horizon was designated the major beneficiary, receiving a \$15,000 donation. "We have teamed up with one of the outstanding not-for-profit organizations in the Buffalo area," said Booker T. Edgerson, president of the Buffalo Bills Alumni Foundation. Horizon, he explained, "is on the front line of this fight...to bring awareness, help and hope to those affected." Events including a gala and auction, a tailgate party and a golf outing are scheduled around the team's home opener.
